The following Tabs and Buttons are available to help you navigate through this process:

Button	Description
In the Portal	
💮 User types	This is used to toggle between various personas within the user profile, such as Taxable Person, Tax Agent, Tax Agency, Legal Representative, etc
(ن⊏	This is used to enable the text to speech feature of the portal
عربي English	This is used to toggle between the English and Arabic versions of the portal
-A A +A	This is used to decrease, reset, and increase the screen resolution of the user interface of the portal
Manage Account	This is used to manage the user profile details such as the Name, Registered Email Address, Registered Mobile Number, and Password
( Log Out	This is used to log off from the portal

Previous Step	This is used to go to the Previous section of the Input Form
Next Step	This is used to go to the Next section of the Input Form
Save as Draft	This is used to save the application as a draft, so that it can be completed later

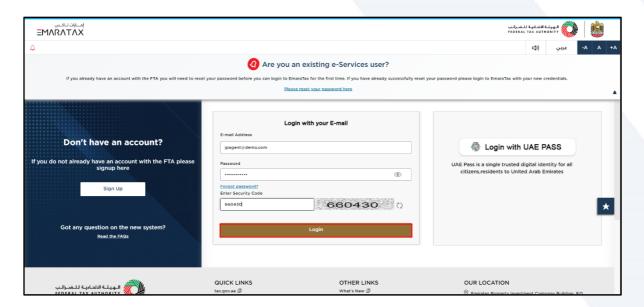
## Introduction

This manual is prepared to help the applicant to navigate through the Federal Tax Authority EmaraTax portal to submit their Juridical Person Tax Agent Registration application. The applicant should be a legal entity with a Trade License to operate as a Juridical Person Tax Agent.





# **Login to EmaraTax**



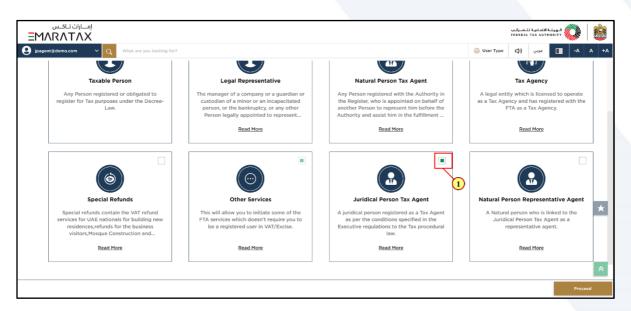


You can login into the EmaraTax account using your login credentials or using UAE Pass. If you do not have an EmaraTax account, you can sign-up for an account by clicking the 'Sign Up' button. If you have forgotten your password, you can use the 'Forgot password?' feature to reset your password.





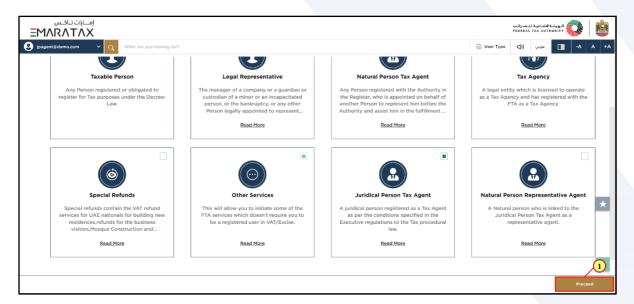

## **Basis of Registration Section**



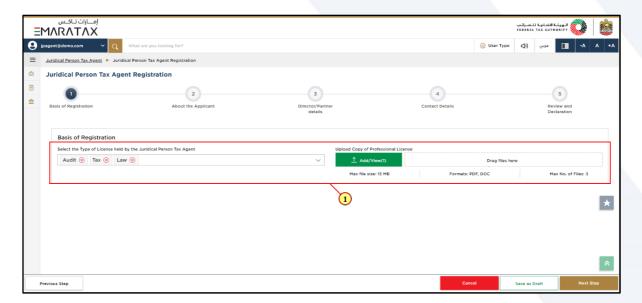




- In order to move from one section to the next, all mandatory fields of the current section
  must be entered. The fields which are optional are marked as optional next to the field
- You are requested to ensure that the documents submitted, support the information entered by you in the application and all the document and details entered by you are up-to-date. This would help to avoid any rejection or resubmission of the application later.



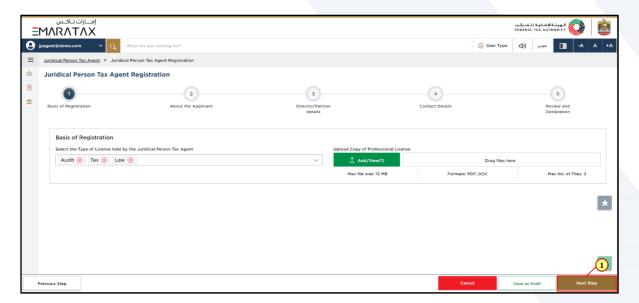

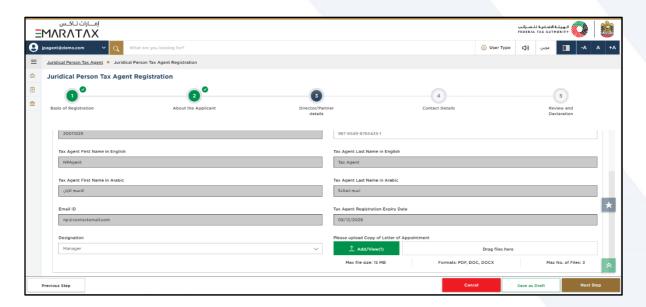
# **Director/Partner details Section**

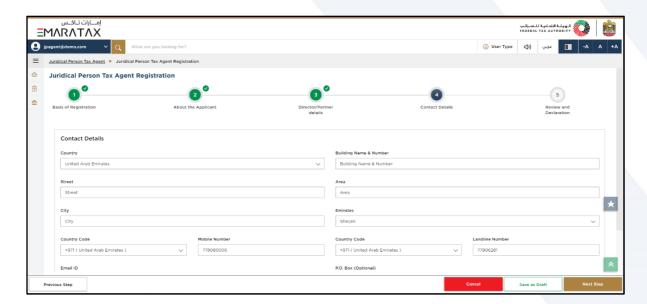
## **Contact Details Section**

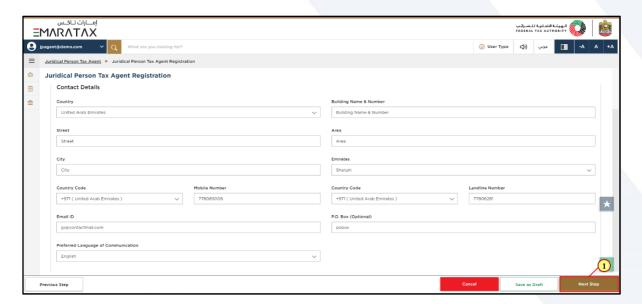




Do not use another company's address. If you have multiple addresses, provide details of the place where most of the day-to-day activities of the business are carried out.





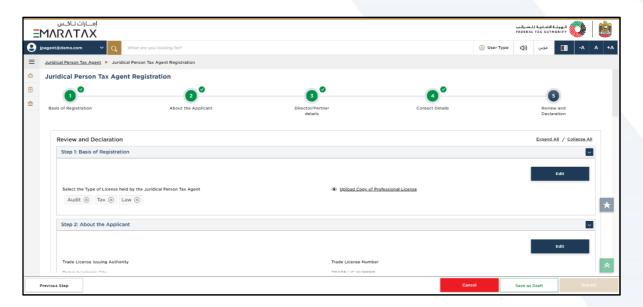

### **Review and Declaration Section**

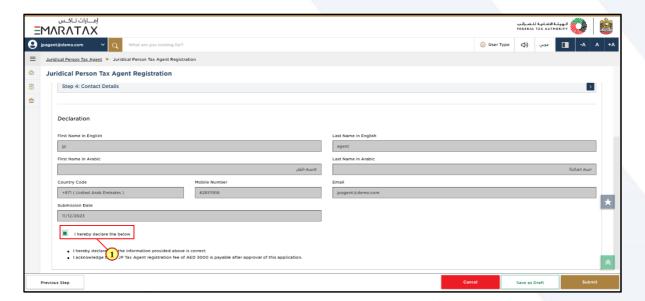




This section highlights all the details entered by you across the application. You are required to review and submit the application.



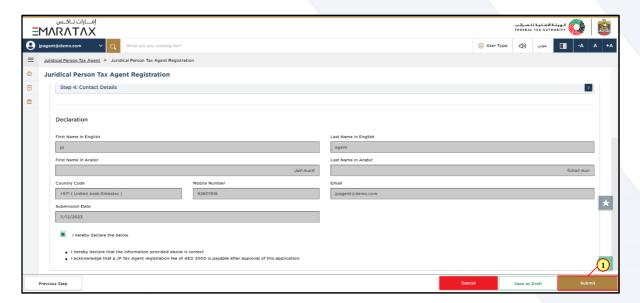

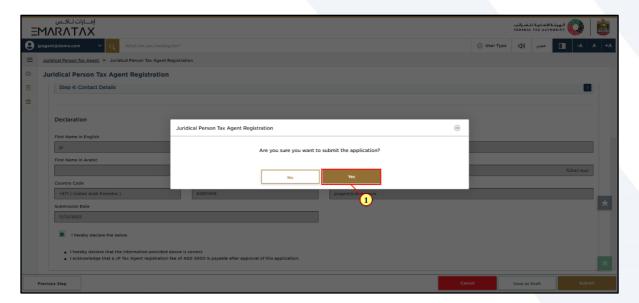

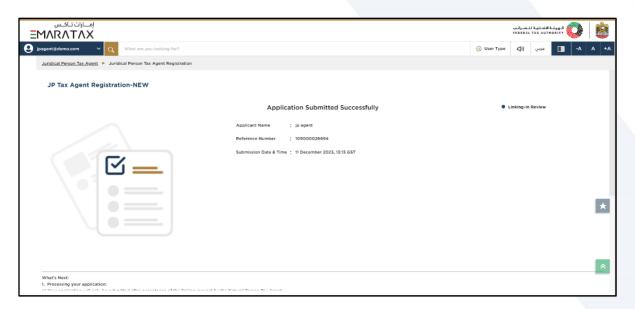

# **Post Application Submission**

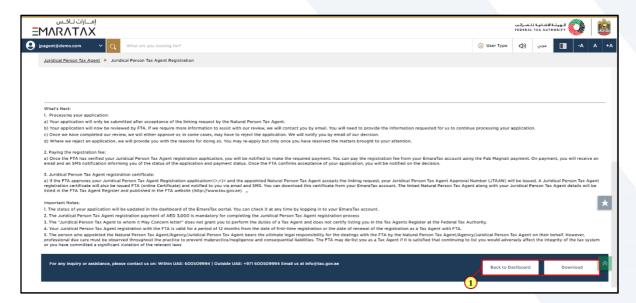

# Correspondences

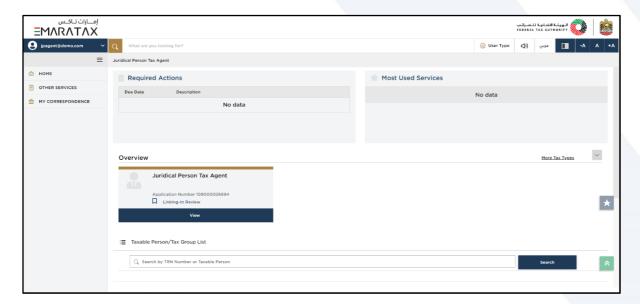
#### Juridical Person Tax Agent receives the following correspondences:

- · Application submission acknowledgment.
- Additional information notification (only if the FTA requires more information to assist with their review of your application).
- Awaiting payment.
- Application approval or rejection notification.





#### Application History - Linking-In Review





Once your application is submitted, a linking request will be sent to the Natural Person Tax Agent and the status of your Juridical Person Tax Agent application will be 'Linking-In Review'.

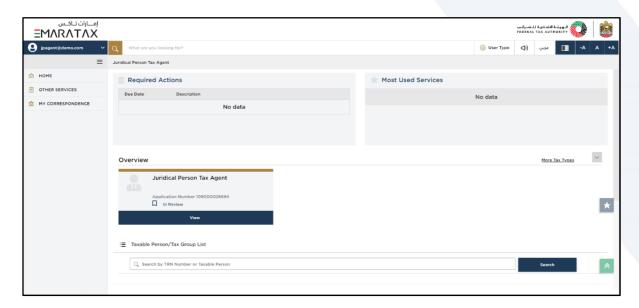




## **Application History - In-Review**

At least one Natural Person Tax Agent should be associated in the position of Director/Manager or any equivalent position, to be able to operate as a Juridical Person Tax Agent.

After the Natural Person Tax Agent approves the Linking request, the application will move to the FTA for review and the status of your application will be 'In-Review'. If the Natural Person Tax Agent rejects the Linking request, the application will be sent back to the Juridical Person Tax Agent.





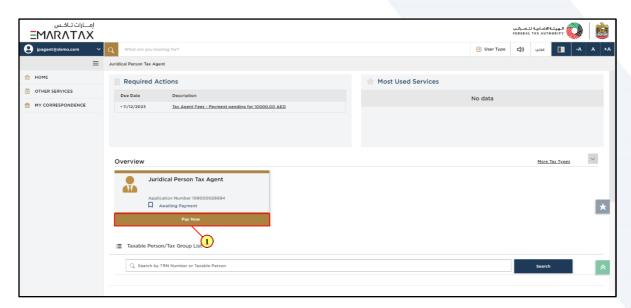
While your application is under review by the FTA, the status of your Juridical Person Tax Agent application will be 'In Review'.





# **Application History - Awaiting Payment**

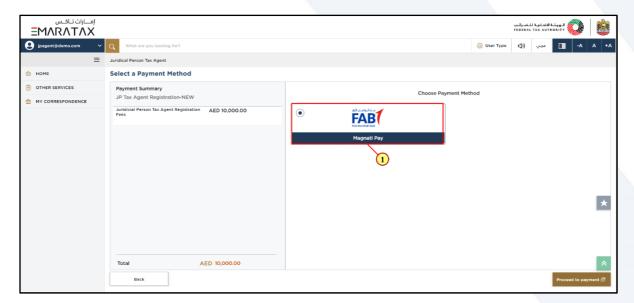
Once the FTA approves your application, you will be informed to make the payment for your Juridical Person Tax Agent Registration.

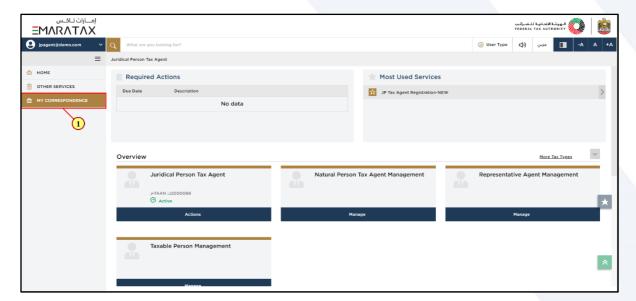




Once the registration process is complete, you will be able to see the J-TAAN ID with 'Active' status on the Juridical Person Tax Agent tile.



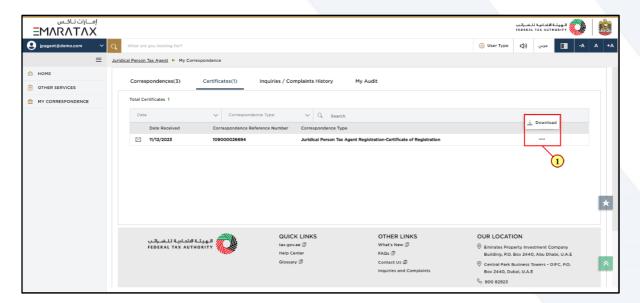
